TERMS AND CONDITIONS

- The bride and groom must sign a wedding video contract before services are rendered.
- A \$100.00 non-refundable deposit is required with contract to secure date and for pre-production video planning.
- If the wedding is cancelled or the date is changed, the initial deposit is forfeited. An additional \$100.00 non-refundable deposit will be required to secure a new wedding date.
- Two weeks prior to event, 50% of remaining balance is due, with the balance of the account due upon delivery of product, unless prior arrangements are made.
- TMT ENTERPRISE accepts money orders and personal checks. There is a \$28.00 fee for any returned checks. If the deposit is paid by check and the check is returned, the contract is void and the date is no longer secured.
- It is the sole responsibility of the client to secure permission of the church, synagogue or other officials to film the ceremony. The deposit is non-refundable if such officials prevent filming. TMT ENTERPRISE will abide by the rules of the church or synagogue regarding camera placement at the ceremony.
- TMT ENTERPRISE will take utmost care to produce a video of good quality. However, we will not be held responsible for circumstances beyond our control, including but not limited to power failure, equipment malfunction, and defective tape stock or client misuse of equipment. If filming is prevented due to such occurrences, all money paid (less deposit) will be refunded. TMT ENTERPRISE makes no guarantees, either expressed or implied, in regard to aesthetic qualities of the completed videotape.
- TMT ENTERPRISE reserves the right to terminate contract for any reason at any time. Should TMT ENTERPRISE terminate contract, all monies paid will be refunded.
- Under any and all circumstances, the total liability of TMT ENTERPRISE is limited to the refund of the deposit.
- All audio and video footage is the copyrighted property of TMT ENTERPRISE. TMT ENTERPRISE reserves the right to use any and/or all footage for promotional purposes.
- The video is strictly produced for the client's private, home use only. Any duplication or broadcast (including internet use) without written consent of TMT ENTERPRISE is strictly prohibited.
- Clients assume all liability for any form of copyright infringement.
- It is the client's sole responsibility to inform TMT ENTERPRISE of any specific needs or changes in events.
- 8% Alabama Sales Tax will be added to packages and additional options.
- A travel charge of \$25.00 will be assessed when wedding related events occur further than 25 miles from each other.
- For wedding and wedding related events in excess of 70 miles of Atlanta, GA, a travel expense of \$100.00 in addition to mileage will be assessed for appropriate lodging and meals.
